Dear Sir,

I am now in receipt of your order blocking this particular writ from being heard in the High Court. Your order was 'on the papers'

Your order is not valid for the following reasons:

1. On the 1st January 2004 the State of Western Australia issued a Declaration of War upon the other States that had formed federation.

2. **The Act of War is identified in the West Australian Act, titled: 'Acts Amendment and Repeal Courts and Legal Practice Act'**

3. You came from the State of Western Australia to join the other six Judges in the High Court.

4. Since the Act of War out of Western Australia beginning 1st January 2004, you have illegally and fraudulently voted in six Commonwealth Elections for both Senators and House of Representatives allegedly representing the State of Western Australia.

5. Since the 1st January 2004 all Commonwealth Politicians are and remain **'Attainted of Treason'**
Such criminal offence is found at Section 44 (ii) of the Commonwealth Constitution Act.

6. Your decision in my matter M99-2019 is nugatory for the very simple fact that you came to the High Court after 2004, which means in Constitutional Law your appointment is illegal.

Your Criminal Offence:

By concealing the material facts evidenced in matter **M99-2019** you have committed a number of criminal offences, specifically:

- A. Concealment of the discovered and revealed treason. In Criminal Law '**Misprison Of Treason**' in both Common Law and Statute Law.
- B. Obtaining Property (Your Salary) by deception.
- C. **Judge in his own cause.** Crimes Act 1914 Cth Section 34.

Your Arrest:

Your Indictment:

Within the Commonwealth Constitution Section 80 grants Trial By Jury '**On indictment**'.

This means that your indictment to stand trial must be based on the legal fact that where the Criminal Offence (your offence) is '**Misprison of Treason**', The indictment for your trial can only be a valid indictment when obtained by Grand Jury.

Grand Jury:

When the State of Western Australia declared their Act of War upon the States of Australia, the only State with Statute Law Grand Jury Provisions was Victoria.

Found at Section 354 Crimes Act 1958 Victoria.

The 54 Grand Jury Defendants:- "**BWS 38**"

In the High Court Matter **M99-2019**, the Matter you have shut out, includes amongst the numerous Exhibits, Exhibit 'BWS 38' which reveals no less than 54 Defendants criminally charged by Private Prosecution via the Magistrates Court of Victoria at Melbourne on various occasions.

On each occasion the **Course of Justice was perverted**, and the Private Prosecutions aborted, but, this perverting of the Course of Justice opened up the Grand Jury right. Your decline of my **High Court Writ "M99-2019"** is an attempt to pervert the Course of Justice, which on its own is a serious indictable offence.

High Court Judges: "BWS38"

Of the 54 Grand Jury Defendants listed and Exhibited as 'BWS 38' seven of these are **seven High Court Judges**, prior, to the fraudulent appointment of the current seven, inclusive of yourself.

You concealed this material fact to grant '**Mates Rates**' or "**Immunity.**"

Robert French:- Former Chief Justice

Came to the High Court in 2008 from the **State of Western Australia**, the same State that you came from.

Kenneth Hayne:- Former High Court Judge

- A. This particular natural person is one of the High Court Judges listed in the 54 Defendants 'BWS 38' pending Grand Jury process, but, has not revealed this material fact since the criminal charge went into position.
- B. **Kenneth Hayne** continued to practice Law within Australia after the criminal charge by concealing this criminal charge from the People of Australia.

1996 – 186 CLR 140:**

- A. The principal issue that McGinty took to the High Court (1995-1996), involved **Section 73(2)** of the Constitution of the State of Western Australia, But, when Governor Sanderson and McGinty Co-Signed this fraudulent enactment to the Overt Act of Treason titled:

'Acts Amendment and Repeal Courts and Legal Practice Act' Section 73 (2) had been completely omitted from the Constitutional process.
'IN SIMPLE TERMS' The People had been left out.

- B. McGinty never finished his 'Articles' meaning in Law **'A Articled Clerk'** became the fraudulent Attorney General for the State of Western Australia.
- C. **'A Articled Clerk' (McGinty)** in agreement with the fraudulent Director of Public Prosecutions **Mr Bugg**, arranged within the State of Western Australia to have myself declared a Vexatious Litigant to prevent Courtroom exposure of the material facts relating to what the **State of Western Australia** had actually done, in agreement with **"The Commonwealth"**.

- A Exhibit 109 exhibited into the **High Court Matter M99-2019** both reveals and discovers the International Occult organization commonly called **'Freemasonry'**.
- B. When the **Western Australian Writ** came into the Supreme Court Master Newnes presiding, the Lawyers for McGinty Stated that the Crown Proceedings Act (WA) had not been abided by.
- C. I pointed out two problems:
1. A Master has no jurisdiction when the **Crown Proceedings Act** is in the litigation.

2. The State of Western Australia has removed **'The Crown'** from the Crown Proceedings Act, at Part 5 of the Overt Act of Treason already named herein.
3. The Writ still sits at the **Western Australia Court of Appeal** yet to be heard, when the Western Australia Supreme Court gains a valid authority.

Wayne Martin:-Former Chief Justice- (BWS 38)

- A. One of the 54 Grand Jury defendants exhibited into the High Court **Matter M99-2019 Exhibit 'BWS 38'** is Wayne Martin because at the time that I criminally charged Mr Martin he occupied the Public Office of Chief Justice of the Supreme Court of the State of Western Australia, But, at **Section 130 of the Overt Act of Treason out of the State of Western Australia**, the Supreme Court Act criminally removed **'The Crown'** in addition to **'Her Majesty Queen Elizabeth the Second'** without any referendum permission.

The 7 Exhibits that you omitted from your Fraudulent judgement are listed at page 30 of this correspondence to yourself.

In relation to David Hurley the current Fraudulent Governor-General, these Exhibits comprise Exhibits BWS 110, BWS 111 and BWS 115.

I wrote to him after reading Section 88 of the Judiciary Act 1903.

The 109 Exhibits you refer to are listed at Exhibit BWS 112

A manuscript document compiled by myself titled "From Pharaoh To The Cross" is Exhibited as BWS 113

The legislation enacted by a Fraudulent Parliament to allegedly permit the asset stripping of Australian Bank Accounts is Exhibited at BWS 116

1. In 2017, the applicant sought to have issued or to file in this Court a document containing a writ and a statement of claim. On 28 November 2017, Gageler J directed the Registrar of this Court to refuse to issue or file the document without the leave of a Justice first had and obtained by the applicant. Nearly two years later, the applicant now seeks that leave. The consequences of the lengthy delay can be put to one side for present purposes. Leave should be refused because the application does not disclose an arguable basis for any of the relief sought.

2. The statement of claim seeks a wide variety of relief in this Court. The primary relief sought is orders that: (i) a petition be filed in this Court to have "the entire election of the most recent Commonwealth election declared invalid"; (ii) "all criminal issues discovered in this legislation ... be remitted to the Full Court [of the] Supreme Court of the State of Victoria for Grand Jury indictments based on lack of jurisdiction for indictments, under Section 42(2) [of the] Judiciary Act 1903 and the High Court of Australia Act 1979, 'Transfer of Proceedings', in addition to Common Law rights"; (iii) "this Originating Application sit sine die until the criminal issues are discovered and ruled upon by jury; that is Grand Jury indictment followed by a State Trial, indictment obtainable by both Statute Law

and Common Law"; and (iv) "[t]he Court submit this originating application Statement of Claim to both Houses of the Commonwealth Parliament in accordance with Section 47 of the Commonwealth Constitution Act 1900". The applicant also seeks alternative relief, and relief described as "[i]n addition", which includes the suspension of the following: all Justices of the High Court of Australia, all staff of the Melbourne Registry of the High Court of Australia, all State Governors, and all current Attorneys-General.

3. The writ and statement of claim which the applicant seeks to file are accompanied by a lengthy affidavit in support with 109 exhibits. I have read all of that material. There is no arguable basis in any of it for any of the relief sought. The application for leave to issue or file should be dismissed without an oral hearing pursuant to r 13.03.1 of the *High Court Rules 2004* (Cth).

2 . **Legislature to be constituted in Western Australia**

(1) There shall be, in place of the Legislative Council now subsisting, a Legislative Council and a Legislative Assembly: and it shall be lawful for Her Majesty, by and with the advice and consent of the said Council and Assembly, to make laws for the peace, order, and good Government of the Colony of Western Australia and its Dependencies: and such Council and Assembly shall, subject to the provisions of this Act, have all the powers and functions of the now subsisting Legislative Council.

(2) The Parliament of Western Australia consists of the Queen and the Legislative Council and the Legislative Assembly.

(3) Every Bill, after its passage through the Legislative Council and the Legislative Assembly, shall, subject to section 73, be presented to the Governor for assent by or in the name of the Queen and shall be of no effect unless it has been duly assented to by or in the name of the Queen.

CONSTITUTION ACT 1889 - SECT 73

(WESTERN AUSTRALIA)

73 . Legislature as constituted by this Act empowered to alter any of its provisions

(1) Subject to the succeeding provisions of this section, the Legislature of the Colony shall have full power and authority, from time to time, by any Act, to repeal or alter any of the provisions of this Act. Provided always, that it shall not be lawful to present to the Governor for Her Majesty's assent any Bill by which any change in the Constitution of the Legislative Council or of the Legislative Assembly shall be effected, unless the second and third readings of such Bill shall have been passed with the concurrence of an absolute majority of the whole number of the members for the time being of the Legislative Council and the Legislative Assembly respectively. Provided also, that every Bill which shall be so passed for the election of a Legislative Council at any date earlier than by Part III provided, and every Bill which shall interfere with the operation of sections 69, 70, 71, or 72, or of Schedules B, C, or D, or of this section, shall be reserved by the Governor for the signification of Her Majesty's pleasure thereon ^{10, 11}.

(2) A Bill that —

(a) expressly or impliedly provides for the abolition of or alteration in the office of Governor; or

(b) expressly or impliedly provides for the abolition of the Legislative Council or of the Legislative Assembly; or

(c) expressly or impliedly provides that the Legislative Council or the Legislative Assembly shall be composed of members other than members chosen directly by the people; or

(d) expressly or impliedly provides for a reduction in the numbers of the members of the Legislative Council or of the Legislative Assembly; or

(e) expressly or impliedly in any way affects any of the following sections of this Act, namely —

sections 2, 3, 4, 50, 51 and 73,

shall not be presented for assent by or in the name of the Queen unless —

(f) the second and third readings of the Bill shall have been passed with the concurrence of an absolute majority of the whole number of the members for the time being of the Legislative Council and the Legislative Assembly, respectively; and

(g) the Bill has also prior to such presentation been approved by the electors in accordance with this section,

and a Bill assented to consequent upon its presentation in contravention of this subsection shall be of no effect as an Act.

(3) On a day fixed by the Governor by Order in Council, being a day not sooner than 2 months, and not later than 6 months, after the passage through the Legislative Council and the Legislative Assembly of a Bill of a kind referred to in subsection (2), the question for the approval or otherwise of the Bill shall be submitted to the electors qualified to vote for the election of members of the Legislative Assembly according to the provisions of the Electoral Act 1907.

(4) When the Bill is submitted to the electors the vote shall be taken in such manner as is fixed by law.

(5) If a majority of the electors voting approve the Bill, it shall be presented to the Governor for assent by or in the name of the Queen.

(6) Any person entitled to vote at a general election of members of the Legislative Assembly is entitled to bring proceedings in the Supreme Court for a declaration, injunction or other remedy to enforce the provisions of this section either before or after a Bill of a kind referred to in subsection (2) is presented for assent by or in the name of the Queen.

MR GAGELER: The express mention of section 73 ought not be interpreted as saying what is being preserved is some special manner of passage through the House in section 73 but not in section 13, because if one looks at section 73, what it does, in addition to regulating the manner of passage through the House, is to impose two conditions that on any view modify or qualify the requirement in section 2(3) that a Bill be presented to the Governor for assent after its passage through the Houses. The two conditions your Honours will see, the first in the concluding words of section 73(1), that certain Bills: shall be reserved by the Governor for the signification of Her Majesty's pleasure thereon. Part 5.1 – Treason and urging violence

Division 80 – Treason and urging violence

1314

80.1A Definition of *organisation*

In this Division: "*organisation*" means:

(a) a body corporate; or

(b) an unincorporated body;

whether or not the body is based outside Australia, consists of persons who are not Australian citizens, or is part of a larger organisation.

Subdivision B – Treason

80.1 Treason

(2) A person commits an offence if the person:

- (a) receives or assists another person who, to his or her knowledge, has committed an offence against this Subdivision (other than this subsection) with the intention of allowing him or her to escape punishment or apprehension; or
- (b) knowing that another person intends to commit an offence against this Subdivision (other than this subsection), does not inform a constable of it within a reasonable time or use other reasonable endeavours to prevent the commission of the offence.

Penalty: Imprisonment for life.

The LORD is righteous; for I have rebelled against his commandment: hear, I pray you, all people, and behold my sorrow: my virgins and my young men are gone into captivity.

The Anguish

Jeremiah 9:1-3

Oh that my head were waters, and mine eyes a fountain of tears, that I might weep day and night for the slain of the daughter of my people! Oh that I had in the wilderness a lodging place of wayfaring men; that I might leave my people, and go from them! for they be all adulterers, an assembly of treacherous men. And they bend their tongues like their bow for lies: but they are not valiant for the truth upon the earth; for they proceed from evil to evil, and they know not me, saith the LORD.

The Health of the Daughter

Jeremiah 9:19-22

For a voice of wailing is heard out of Zion, How are we spoiled! we are greatly confounded, because we have forsaken the land, because our dwellings have cast us out. Yet hear the word of the LORD, O ye women, and let your ear receive the word of his mouth, and teach your daughters wailing, and every one her neighbour lamentation. For death is come up into our windows, and is entered into our palaces, to cut off the children from without, and the young men from the streets. Speak, Thus saith the LORD, Even the carcasses of men shall fall as dung upon the open field, and as the handful after the harvestman, and none shall gather them.

Thy King

Zechariah 9:9

Rejoice greatly, O daughter of Zion; shout, O daughter of Jerusalem: behold, thy King cometh unto thee: he is just, and having salvation; lowly, and riding upon an ass, and upon a colt the foal of an ass.

Matthew 21:5

Tell ye the daughter of Sion, Behold, thy King cometh unto thee, meek, and sitting upon an ass, and a colt the foal of an ass.

Salvation/Redeemed

Isaiah 62:11-12

Behold, the LORD hath proclaimed unto the end of the world, Say ye to the daughter of Zion, Behold, thy salvation cometh; behold, his reward is with him, and his work before him. And they shall call them, The holy people, The redeemed of the LORD: and thou shalt be called, Sought out, A city not forsaken.

Psalms 9:11-14

Sing praises to the LORD, which dwelleth in Zion: declare among the people his doings. When he maketh inquisition for blood, he remembereth them: he forgetteth not the cry of the humble. Have mercy upon me, O LORD; consider my trouble which I suffer of them that hate me, thou that liftest me up from the gates of death: That I may shew forth all thy praise in the gates of the daughter of Zion: I will rejoice in thy salvation.

Zephaniah 3:12-20

I will also leave in the midst of thee an afflicted and poor people, and they shall trust in the name of the LORD. The remnant of Israel shall not do iniquity, nor speak lies; neither shall a deceitful tongue be found in their mouth: for they shall feed and lie down, and none shall make them afraid. Sing, O daughter of Zion; shout, O Israel; be glad and rejoice with all the heart, O daughter of Jerusalem. The LORD hath taken away thy judgments, he hath cast out thine enemy: the king of Israel, even the LORD, is in the midst of thee: thou shalt not see evil any more. In that day it shall be said to Jerusalem, Fear thou not: and to Zion, Let not thine hands be slack. The LORD thy God in the midst of thee is mighty; he will save, he will rejoice over thee with joy; he will rest in his love, he will joy over thee with singing. I will gather them that are sorrowful for the solemn assembly, who are of thee, to whom the reproach of it was a burden. Behold, at that time I will undo all that afflict thee: and I will save her that halteth, and gather her that was driven out; and I will get them praise and fame in every land where they have been put to shame. At that time will I bring you again, even in the time that I gather you: for I will make you a name and a praise among all people of the earth, when I turn back your captivity before your eyes, saith the LORD.

The Dust

Isaiah 52:2

Shake thyself from the dust; arise, and sit down, O Jerusalem: loose thyself from the bands of thy neck, O captive daughter of Zion.

Babylon (Daughter of Babylon)

Zechariah 2:7-12

Deliver thyself, O Zion, that dwellest with the daughter of Babylon. For thus saith the LORD of hosts; After the glory hath he sent me unto the nations which spoiled you: for he that toucheth you toucheth the apple of his eye. For, behold, I will shake mine hand upon them, and they shall be a spoil to their servants: and ye shall know that the LORD of hosts hath sent me. Sing and rejoice, O daughter of Zion: for, lo, I come, and I will dwell in the midst of thee, saith the LORD. And many nations shall be joined to the LORD in that day, and shall be my people: and I will

dwell in the midst of thee, and thou shalt know that the LORD of hosts hath sent me unto thee. And the LORD shall inherit Judah his portion in the holy land, and shall choose Jerusalem again.

Isaiah 47:1-6

Come down, and sit in the dust, O virgin daughter of Babylon, sit on the ground: there is no throne, O daughter of the Chaldeans: for thou shalt no more be called tender and delicate. Take the millstones, and grind meal: uncover thy locks, make bare the leg, uncover the thigh, pass over the rivers. Thy nakedness shall be uncovered, yea, thy shame shall be seen: I will take vengeance, and I will not meet thee as a man. As for our redeemer, the LORD of hosts is his name, the Holy One of Israel. Sit thou silent, and get thee into darkness, O daughter of the Chaldeans: for thou shalt no more be called, The lady of kingdoms. I was wroth with my people, I have polluted mine inheritance, and given them into thine hand: thou didst shew them no mercy; upon the ancient hast thou very heavily laid thy yoke.

Redeemed

Micah 4:10-13

Be in pain, and labour to bring forth, O daughter of Zion, like a woman in travail: for now shalt thou go forth out of the city, and thou shalt dwell in the field, and thou shalt go even to Babylon; there shalt thou be delivered; there the LORD shall redeem thee from the hand of thine enemies. Now also many nations are gathered against thee, that say, Let her be defiled, and let our eye look upon Zion. But they know not the thoughts of the LORD, neither understand they his counsel: for he shall gather them as the sheaves into the floor. Arise and thresh, O daughter of Zion: for I will make thine horn iron, and I will make thy hoofs brass: and thou shalt beat in pieces many people: and I will consecrate their gain unto the LORD, and their substance unto the Lord of the whole earth.

The Chariot

Micah 1:13

O thou inhabitant of Lachish, bind the chariot to the swift beast: she is the beginning of the sin to the daughter of Zion: for the transgressions of Israel were found in thee.

2 Kings 2:11-12

And it came to pass, as they still went on, and talked, that, behold, there appeared a chariot of fire, and horses of fire, and parted them both asunder; and Elijah went up by a whirlwind into heaven. And Elisha saw it, and he cried, My father, my father, the chariot of Israel, and the horsemen thereof. And he saw him no more: and he took hold of his own clothes, and rent them in two pieces.

The Tower

Micah 4:8

And thou, O tower of the flock, the strong hold of the daughter of Zion, unto thee shall it come, even the first dominion; the kingdom shall come to the daughter of Jerusalem.

The Hill of Jerusalem

Isaiah 10:32


As yet shall he remain at Nob that day: he shall shake his hand against the mount of the daughter of Zion, the hill of Jerusalem.
