The Constitution of each State of the Commonwealth shall, subject to this Constitution, continue as at the establishment of the Commonwealth, or as at the admission or establishment of the State, as the case may be, "until altered in accordance with the Constitution of the State".

#### Western Australia Constitution Section 73.2

CONSTITUTION ACT 1889 - SECT 73

Legislature as constituted by this Act empowered to alter any of its provisions

- (2) A Bill that ---
- (a) expressly or impliedly provides for the abolition of or alteration in the office of Governor; or
- (b) expressly or impliedly provides for the abolition of the Legislative Council or of the Legislative Assembly; or
- (c) expressly or impliedly provides that the Legislative Council or the Legislative Assembly shall be composed of members other than members chosen directly by the people; or
- (d) expressly or impliedly provides for a reduction in the numbers of the members of the Legislative Council or of the Legislative Assembly; or
- (e) expressly or impliedly in any way affects any of the following sections of this Act, namely sections 2, 3, 4, 50, 51 and 73, shall not be presented for assent by or in the name of the Queen unless —
- (f) the second and third readings of the Bill shall have been passed with the concurrence of an *absolute majority* of the whole number of the members for the time being of the Legislative Council and the Legislative Assembly, respectively; and
- (g) the Bill has also prior to such presentation been approved by the electors in accordance with this section, and a Bill assented to consequent upon its presentation in contravention of this subsection shall be of no effect as an Act.

#### The Unlawful Australia Act 1986

In the period 1984/1986 the Prime Minister of the Commonwealth Mr R Hawke and the Premiers of the States agreed to omit the binding requirements found in Section 128 of the Commonwealth of Australia Constitution Act 1900, but, chose Section 51(xxxviii) of such Constitution instead herein quoted

#### COMMONWEALTH OF AUSTRALIA CONSTITUTION ACT - SECT 51

Legislative powers of the Parliament

The Parliament shall, *subject to this Constitution*, have power to make laws for the peace, order, and good government of the Commonwealth with respect to:

(xxxviii) the exercise within the Commonwealth, at the request or with the concurrence of the Parliaments of all the States directly concerned, of any power which can at the establishment of this Constitution be exercised only by the Parliament of the United Kingdom or by the Federal Council of Australasia;

#### Royal Assent

After the unlawful enactment of the Australia Act in 1986 the Governor General plus State Governors assumed an unlawful authority to sign Royal Assent to Bills previously needing "reservation" for lack of Jurisdiction

#### Australia Act 1986 Section 6

AUSTRALIA ACT 1986 - SECT 6

Manner and form of making certain State laws

Notwithstanding sections 2 and 3(2) above, a law made after the commencement of this Act by the Parliament of a State respecting the constitution, powers or procedure of the Parliament of the State shall be of no force or effect unless it is made in such manner and form as may from time to time be required by a law made by that Parliament, whether made before or after the commencement of this Act.

# The West Australian Discontent: Is Secession Possible?

#### Introduction

Like the rumblings of a distant storm-centre there have been heard, several times since the establishment of the Australian Commonwealth, suggestions made, speeches delivered, and resolutions passed in some of the States in favour of secession and separation. In New South Wales, Queensland, and Western Australia members of the State Parliaments and local agitators have complained of certain actions, or neglect of the Federal Parliament, which they considered inconsistent with State rights and State interest, justifying, in their opinion, resort not merely to protest and remonstrance (well within their province), but to threats of withdrawal from the union. In New South Wales there has been much discontent and grumbling about the delay in the settlement of the Federal Capital, and the continuance of the seat of government in Melbourne. In Queensland a great stir has been made on account of the loss of revenue and the abolition of Kanaka labour in sugar plantations.

#### The West Australian Grievance

In Western Australia the principal grievance has been the delay of Parliament in sanctioning the survey of the proposed transcontinental railway from Port Augusta to Kalgoorlie. The recent failure of the Senate, by one vote, to pass the Survey Bill, sent up to it by the House of Representatives, appears to have aroused a storm of indignation in the western State. Clamour and demonstration against the Commonwealth has culminated in a resolution being passed by the Legislative Assembly on September 26, affirming that "The union of Western Australia with the other States has proved detrimental to the best interests of the State, and that the time has arrived for placing before the people the question of withdrawal from the union."

## Secession Resolution a Nullity

The all-important point to consider is the possible effect of such a resolution, and whether the State Parliament can take action to give effect to it? The clear and unanswerable reply is, that such menaces and fulminations are absolutely useless, and that any movement of the kind is doomed to be abortive, and to cover with ridicule those responsible for such impotent resolutions.

Personally, I favour, and voted for, the Survey Bill, and the great preponderance of members of the House of Representatives supported it. It is not true, therefore, to allege "that unfair treatment has been meted out to Western Australia by the representatives of the majority of the signatories of the Federal compact." The National House of the Common wealth, voicing the views of the majority of members in the majority of States, has twice passed the Bill, and twice in two successive sessions sent it to the Senate, where it has been twice defeated, or, rather, suspended, by a majority of one. The Chamber which is supposed to represent State rights and interests, and in which Western Australia is represented by as many Senators as Victoria, is responsible for the miscarriage of the Bill; the House in which the whole people of the Commonwealth are proportionally represented, has endeavoured to give effect to the wishes of Western Australia. It seems, therefore, most unfair to blame either the Federal Union or the Federal Government, or the majority of the people's [P.927] House, for what has happened. It is, in fact, outrageous to include in such unwarrantable declarations.

#### An Indestructible Union

Perhaps it would be just as well to shortly explain that Western Australia, like other States, has freely and voluntarily joined the Commonwealth in the full knowledge that it is not a mere compact or partnership, dissolvable at will, like the old Australian Federal Council, but that it is an indissoluble Federal Commonwealth. In the memorable words of one of the judges of the Supreme Court of the United States of America, referring to the nature and character of the American Constitution: "It is an indestructible union, composed of indestructible States."—Chase, C. J., in Texas v. White, 7 Wall., 700. The indissolubility of the Australian bond is clearly and expressly affirmed in the preamble to the Constitution. The words are: "Whereas the people . . . have agreed to unite in one indissoluble Federal Constitution under the Crown, . . . and under the Constitution hereby established." The Constitution was drawn up in Australia, but it was enacted by the Imperial Parliament of Great Britain. No power in Australia can repeal or alter the clauses of the Imperial Act, under which, on September 17, 1900, the late Queen's proclamation was issued, declaring that on and after the first day of January, 1901, the people of New South Wales, Victoria, South Australia, Queensland, Tasmania, and Western Australia should be united into a Federal Constitution, under the name of the Commonwealth of Australia. No amendment of the Constitution, releasing any State from its membership of the Commonwealth, can be made either by the Federal Parliament, or by any State Legislature. New States may be admitted into the family circle of the Commonwealth by the Federal Parliament, but it cannot, if it desired, expel or release any State from the Union. The British Parliament alone could do so, and it is not likely that under any conceivable circumstances would that Parliament, which has called the Commonwealth into existence, be a party to its destruction. It may be interesting to show how the doctrine of secession from a Federal

Union originated in the United States of America, and how that doctrine was for ever exploded, amid the ruin and bloodshed of a civil war, which thrilled the world.

#### American Precedents

The omission from the Constitution of the United States of an express declaration of the permanence and indestructibility of the Union, led to the promulgation of the disastrous doctrines of nullification and secession, which were not finally abandoned until the Civil War of 1862-4 forever terminated the controversy. The Kentucky and Virginia Resolutions, drafted by Jefferson (1798), and adopted by the Legislatures of those States, in protest against the Alien and Sedition Laws passed by the Federal Congress, contained the germ of the fatal and insidious contention that the Union was merely a compact among the States; that the States, severally, had the right to resist any breach of the compact, and to pronounce that a Legislative Act of the Federal Congress in excess of its powers, and encroaching on the rights of the States, was a nullity to be followed, if necessary, by resistance, revolution, and bloodshed.

In October, 1832, a State Convention was held in South Carolina, at which it was declared and ordained by the people of the State that the several Acts of Congress purporting to impose duties on the importation of foreign commodities were unauthorised by the constitution of the United States, and were therefore utterly null and void.

This was the first serious experiment in nullification by any State. The State Legislature of South Carolina followed up the ordinances of the State Convention by passing several Acts intended to give effect to the declaration of nullification, by authorising the citizens of the State to refuse to obey the Federal Law, which had been declared null and void. The President of the Republic, General Jackson, issued a proclamation to the people of South Carolina, requiring them to obey the Federal Law, and he followed up his proclamation by calling out the Federal troops. Hayne, the Governor of the State, responded by mustering and drilling 20,000 volunteers. Jackson is said to have sent a private message to Calhoun threatening that he would hang him higher than Haman, if nullification were not abandoned. An armed conflict between the State and the Union was only averted by a compromise, according to which Congress passed a new tariff law redressing some of the grievances complained of; and the controversy for the time was terminated.

## The Logic of War

Calhoun's policy had been successful, and the result encouraged his successors when they put to the test their claim to the right of secession from the Union. The contest was

resumed in a more dangerous shape on December 20, 1860, when a convention of the people of South Carolina was held, at which an ordinance of secession was adopted.

This ordinance of secession was followed up by a declaration of independence; which alleged that the Union was dissolved, and that South Carolina had resumed her position amongst the nations of the world as a free, sovereign and independent State. The example of South Carolina was afterwards followed by the States of Mississippi, Florida, Alabama, Georgia, Louisiana, and Texas. A congress of seceding States was held at Montgomery, Alabama, at which a provisional constitution was adopted, and a provisional Government was formed. The Confederate constitution was in many respects similar to that of the United States. In April, 1861, the provisional Government was called upon to give orders relating to Fort Sumter, a fortification still held by the United States, but situated within the territory of one of the Confederate States; the militia of South Carolina were directed to attack the fort, and the [P.934] Civil War began. Four other States, Virginia, North Carolina, Tennessee and Arkansas, then seceded from the Union.

The war was declared ended in August, 1866. Although the Federal constitution was not amended by the insertion of a new clause explicitly stating that the Union was a permanent form of Government, several State constitutions, including those of seven of the rebellious States, were amended by the introduction of provisions expressly repudiating the right of secession. It was at a fearful cost that the principle was thus, once and for all, placed beyond the region of doubt that the United States form a perpetual union of indestructible States.

#### Canada

The constitution of Canada does not contain any clause declaring the perpetuity or indissolubility of the Dominion. The constitution is embodied in an Imperial Act, and, save with respect to certain matters of detail not affecting the fundamental features of the scheme, it can only be altered by the Imperial Parliament. No general power to amend the constitution has been granted to the Parliament and people of Canada. Consequently, the Dominion is absolutely indissoluble so far as the Parliament and people of Canada are concerned.

#### The Commonwealth

These considerations explain the circumstances that the Canadian constitution contains no reference to the durability, or otherwise, of the Dominion. They do not account for the fact that, whilst the indissolubility of the Commonwealth is not affirmed by any clause in the Imperial Act, it is recited as an accepted principle in the preamble. Why was it placed in the preamble? The only reason which can be suggested is that the Australian Parliament and

people have a general power to amend the constitution, and it may have been considered wise and prudent that, coupled with a right so great and important, there should be a reminder, placed in the fore-front of the deed of political partnership between the federating colonies, that the union, sealed by Imperial Parliamentary sanction, was intended by the contracting parties to be a lasting one, and that no alteration should be suggested or attempted inconsistent with the continuity of the Commonwealth as an integral part of the British Empire.

#### Maintenance of Commonwealth Unity

I cannot see how any State could withdraw from the Commonwealth without the authority of the Imperial Parliament. By the constitution the Customs and Excise Departments, the Post and Telegraph Departments, with all their vast sources of revenue, are vested in the Commonwealth, and they are manned and administered by Commonwealth officers, the surplus revenue being paid over to the States every month. The Defence Forces also are vested in the Commonwealth. If the Government of Western Australia, or of any recalcitrant State, attempted to take possession of the Customs House, or the Post Office, the Federal militia would be called out to defend Commonwealth property. That would soon put an end to the disturbance. There is a method of obtaining redress of State grievances without resorting to force.

## 34. "Shall be Binding on the Courts, Judges and People."

5 Operation of the Constitution and laws [see Note 3] of Constitution of the Australian Commonwealth

This Act, and all laws made by the Parliament of the Commonwealth under the Constitution, shall be binding on the courts, judges, and people of every State and of every part of the Commonwealth, notwithstanding anything in the laws of any State;

The importance of these words, as indicating one of the fundamental principles of the Constitution, should be specially noted.

They make Clause 5 of the Commonwealth Constitution Act substantially similar in scope and intention to article VI. sec.2 of the Constitution of the United States, *supra*. Under this clause, the Act, the Constitution, and laws of the Commonwealth made in pursuance of its powers, will be the supreme law of the land, binding on the Courts, Judges, and people of every State, notwithstanding anything to the contrary in the laws of any State.

The latter words operate as a rescission of all State laws incompatible with the Act, with the Constitution, and with such laws as may be passed by the Parliament of the Commonwealth in the exercise of its Constitutional rights. Therefore, by this clause, coupled with sections 106 to 109, all the laws of a State, constitutional as well as ordinary, will be in effect repealed so far as they are repugnant to the supreme law. All the laws of any State, so far as not inconsistent with the supreme law, will remain in force until altered by the proper authority.

The pre-eminent significance of this direct action of the federal laws on the Courts, Judges, and people, is that it forms a distinctly national feature of the Constitution and differentiates it from the weakness and imperfection of a confederate system of government. The constitutional value of these words will be better appreciated by comparing this Constitution with the Articles of Confederation of the American States (1781), from which they are absent.

The British Parliament, being a sovereign legislature, may pass laws binding on its subjects all over the world; but, according to the principles of international law, it ought not to legislate for foreigners out of its dominions and beyond the jurisdiction of the Crown. (Lopez v. Burslem, 4 Moo. P.C., 300: the Zollverein, 1 Swab. Adm., 96.) The British Parliament has not, according to the principles of public law, any authority to legislate for foreign vessels on the high seas or for foreigners beyond the frontiers of the Empire.(Reg. v. Keyn, 2 Ex. D. 220.)

"But the laws of the Commonwealth being those of a subordinate and non-sovereign legislature would be examinable by the Courts, and if it appeared that they purported to legislate for matters outside the limits of the Commonwealth they would be pronounced ultra vires and null and void".

#### 36 "The Laws of Any State."

The laws of the States will comprise the following classes:—

- □(i.) Imperial Acts relating to the Constitution and government of the colonies when they become States:
- $\Box\Box$  (ii.) Imperial Acts relating to matters of ordinary legislation expressly applicable to the colonies when they become States:
- □□(iii.) The Common law so far as applicable and not modified by colonial or State legislation:
- $\Box\Box$ (iv.) Laws of the realm of England made applicable to some colonies by the general terms of the Act of 9 George IV. c. 83, and not since repealed or amended by colonial legislation:
- □□(v.) Acts relating to constitutional matters as well as to matters of ordinary legislation passed by the colonial or State legislatures in the exercise of Statutory authority conferred by Imperial law.

All these laws will remain in full force and effect until they become inconsistent with—(1) The Commonwealth of Australia Constitution Act, or (2) some Act amending the Constitution, or (3) laws to be made thereunder by the Parliament of the Commonwealth. By the Constitution of the colonies their legislatures have power to make laws in and for those colonies respectively in all cases whatsoever. When those [P.357] colonies become States their large powers will by degrees be considerably cut down, although they will be compensated for the loss of direct authority by their representation in the Federal Parliament. The jurisdiction of that Parliament will over-lap and in time will considerably contract the realm of State jurisdiction. As the federal legislation within the area of enumerated powers acquires activity and increases in volume, the State laws within that area will be gradually displaced by federal laws, but until they are so displaced through repugnancy they will retain their original vitality and be binding on the people of their respective States.

Should the British Parliament in violation of those principles attempt to render foreigners subject to its laws with reference to offences committed beyond its territorial limits, it would be incumbent on the Courts of the Empire to enforce those enactments, leaving it to the Imperial Government to settle the question of international law with the governments of the nations concerned.

But the laws of the Commonwealth being those of a subordinate and nonsovereign legislature would be examinable by the Courts, and if it appeared that they purported to legislate for matters outside the limits of the Commonwealth they would be pronounced *ultra vires* and null and void.

#### 37. "The Laws of the Commonwealth."

This is a more suitable and comprehensive expression than the one which appears at the beginning of this clause, viz., "this Act and all laws made by the Parliament of the Commonwealth." The laws of the Commonwealth will consist of the following classes:—

□□(I.) The Commonwealth of Australia Constitution Act.
□□(II.) Alterations of the Constitution pursuant to the provisions of Chapter VIII.
□□(III.) Laws made by the Parliament of the Commonwealth under the Constitution.
It will be noticed that the second group of laws as above classified will not be laws made by the Parliament; they may be laws proposed either by one or both of the Federal Chambers, subject to certain conditions, and afterwards approved by the qualified electors of the Commonwealth and assented to by the Governor-General or by the Queen.

James 2:10 He who breaks the least of these Commandments and teaches others to do so is guilty of all.





Relating to due process; to prohibit the State of Alabama and its political subdivisions from adopting and developing environmental and developmental policies that, without due process, would infringe or restrict the private property rights of the owner of the property.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

2.18 Mr Charles demonstrated the difficulties by reference to his own position:

...it is virtually impossible to relieve an individual who is born overseas of all of their potential residual rights in the country of their birth, or a prior country of occupation. I cite for the record the fact that because I grew up in the United States, where there is a different kind of social security system from what we have here, at age 13, when I took my first job, I applied for and gained a social security number, which meant that I paid taxes to the American government for potential social security benefits and continued to pay those for many years. That amount has accrued to my account.

...

... even though I am an Australian citizen I have an absolute right to that benefit. It would be unconscionable for you to say to me that I could no longer be a member of this parliament because I have a right to a social security benefit for which I worked in another country at another time.... [T]he larger part of that argument is that these inconsequential rights and entitlements certainly should not disqualify one from office. <sup>26</sup>

2.19 Professor Blackshield supported the view that the words 'entitled to the rights or privileges' raise particular problems. As noted above, during the 1980s, the then Prime Minister, the Hon RJL Hawke was threatened with a challenge under subsection 44(i) because he had been made an honorary citizen of Israel. Professor Blackshield commented that in fact there is an argument that the conferral of honorary citizenship had entitled the Hon RJL Hawke to the rights and privileges of a citizen of the state of Israel and that he was in fact disqualified.<sup>27</sup> Significantly, no legal challenge was issued.

#### Mode of prosecution

"All treasons and misprisions of treason shall be prosecuted by indictment only, and all other indictable offences may be prosecuted by indictment or by presentment as hereinafter directed."

## 4. CRIMES ACT 1958 VICTORIA - SECTION 322E

## Treason and misprision of treason not affected

"Nothing in this Part shall be taken to affect directly or indirectly any matter of law or practice applicable to treason or misprision of treason."

## CRIMES ACT 1958 VICTORIA – SECTION 316

Unlawful oaths to commit treason, murder etc.

- (1) Every person who--
  - (a) Administers or is present at and consents to the administering of any oath or engagement in the nature of an oath purporting to bind the person who takes it to commit treason or murder; or
- (2) Every person who--
  - (a) administers or is present at and consents to the administering of any oath or engagement in the nature of an oath purporting to bind the person who takes it to act in any of the ways following (that is to say):—
    - (ii) To commit any indictable offence other than treason or murder;

(vii) not to reveal or discover any unlawful association society or confederacy or any illegal act done or to be done or any illegal oath or engagement that may have been administered or tendered to or taken by himself or any other person or the import of any such oath or engagement, or

shall be guilty of an indictable offence, and shall be liable to level 6 imprisonment (5 years maximum).

Division 80 Concealment or Assistance

- (2) A person commits an offence if the person:
  - (a) Receives or assists another person who, to his or her knowledge, has committed treason with the intention of allowing him or her to escape punishment or apprehension; or
  - (b) Knowing that another person intends to commit treason, does not inform a constable of it within a reasonable time or use other reasonable endeavours to prevent the commission of the offence.

Penalty: Imprisonment for Life

## 8. JUDICIARY ACT 1903 (CTH) SECTION 80

#### Common law to govern

So far as the laws of the Commonwealth are not applicable or so far as their provisions are insufficient to carry them into effect, or to provide adequate remedies or punishment, the common law in Australia as modified by the Constitution and by the statute law in force in the State or Territory in which the Court in which the jurisdiction is exercised is held shall, so far as it is applicable and not inconsistent with the Constitution and the laws of the Commonwealth, govern all Courts exercising federal jurisdiction in the exercise of their jurisdiction in civil and criminal matters.

## 9. TREASON & MISPRISON OF TREASON:

Must be by Grand Jury Exclusively

- a. Byrne V Armstrong (1899) 25 VLR 126 (The Indictment)

  "That section contemplates an exparte application founded upon an affidavit disclosing an indictable offence, and that a justice has refused to commit. The court has no discretion once those conditions are complied with. Section 386 shows that so far as Treason is concerned it must be prosecuted by indictment. The Attorney General could not start such a prosecution. It must be by grand jury." (at 126)
- b. Byrne V Armstrong (1899) 25 VLR 126 (The Finding)

  "It is provided now that all the prosecutions shall be by presentment, but preserving the prerogative of the Crown through the Attorney General to proceed by information, except in case of 'treason' which has to be by indictment Now indictment means by Grand Jury and therefore, inasmuch as the statute provides that Treason shall be tried by indictment only. That means that it must be by Grand Jury and no other means is provided for bringing it before a Grand Jury." The finding of the Attorney General is

equivalent to the finds of the Grand Jury, but in the case of Treason it must be the finding of the Grand Jury." (at 132)

c. McArdle V Lorne Campbell (Sept 1986) (On Behalf of the Crown)

"Much has changed since 1940 and in particular the Office of Director of
Public Prosecutions has been established by Act No 9848 of 1982. Under that
Act the Director of Public Prosecutions is charged with preparing, instituting
and conducting criminal proceedings on 'behalf of the Crown.' The
Director is responsible to the Attorney General for the due performance of his
functions and he is given the power to enter a nolle prosequi in criminal
proceedings. But the Attorney-General's power to enter a nolle prosequi is
preserved in these circumstances, now that the responsibility for instituting
criminal proceedings has been taken out of the hands of the Attorney-General,
it may be that there is not the same need to have an alternative method of
instituting proceedings. When the Office of Director of Public Prosecutions
was established S354 of the Crimes Act was amended to substitute the words
'the Director or Public Prosecutions' for the words 'a law officer.' The
section therefore now operates where the Director declines to present.''

"The tria! on indictment of any offence against any law of the Commonwealth shall be by jury, and every such trial shall be held in the State where the offence was committed, and if the offence was not committed within any State the trial shall be held at such place or places as the Parliament prescribes."
