


# The Course of Justice The Issue at hand:

#### The Correction

Ezra Chapter 7. 23/27

Whatsoever is commanded by the God of heaven let it be diligently done for the house of the God of heaven: for why should there be wrath against the realm of the king and his sons?

Also we certify you that touching any of the priests and Levites singers porters Nethinims or ministers of this house of God it shall not be lawful to impose toll, tribute or custom, upon them.
