shall be incapable of being chosen or of sitting as a senator or a member of the House of Representatives.

The Fabian Socialist Speech

We have been able to identify that Mr Hawke, the Fabian Society Israel agent operating within Australia; during this time that he was able to achieve this office of Prime Minister was the key speaker at the 1984 inaugural speech celebrating the 1884 foundation of the Fabian Society. The Constitution Section 106

The Constitution of each State of the Commonwealth shall, subject to this Constitution, continue as at the establishment of the Commonwealth, or as at the admission or establishment of the State, as the case may be, until altered in accordance with the Constitution of the State.

The immediate fraud

We have discovered that by using section 51 (xxxviii) rather than Section 128(the referendum section) and involving the various State Parliaments (former colonies) three particular states omitted their statutory referendum requirements

- 1. Western Australia
- 2. Queensland
- 3. New South Wales

The Australia Act 1986

We have discovered that emanating from the "1984 Coffee Shop Cabal" Mr Hawke the socialist, Communist Israel agent and his co-conspirators were able to obtain and cause be enacted the "Australia Act" without one referendum being conducted, either at State or Commonwealth levels and as such this Constitutional omission invalidates the Australia Act.

- ¹⁰ Therefore thus saith the Lord GOD; Because thou hast lifted up thyself in height, and he hath shot up his top among the thick boughs, and his heart is lifted up in his height;
- ¹¹ I have therefore delivered him into the hand of the mighty one of the heathen; he shall surely deal with him: I have driven him out for his wickedness.
- ¹² And strangers, the terrible of the nations, have cut him off, and have left him: upon the mountains and in all the valleys his branches are fallen, and his boughs are broken by all the rivers of the land; and all the people of the earth are gone down from his shadow, and have left him.
- ¹³ Upon his ruin shall all the fowls of the heaven remain, and all the beasts of the field shall be upon his branches:
- ¹⁴ To the end that none of all the trees by the waters exalt themselves for their height, neither shoot up their top among the thick boughs, neither their trees stand up in their height, all that drink water: for they are all delivered unto death, to the nether parts of the earth, in the midst of the children of men, with them that go down to the pit.
- ¹⁵ Thus saith the Lord GOD; In the day when he went down to the grave I caused a mourning: I covered the deep for him, and I restrained the floods thereof, and the great waters were stayed: and I caused Lebanon to mourn for him, and all the trees of the field fainted for him.
- ¹⁶ I made the nations to shake at the sound of his fall, when I cast him down to hell with them that descend into the pit: and all the trees of Eden, the choice and best of Lebanon, all that drink water, shall be comforted in the nether parts of the earth.

The Government

We have discovered that the Prophet Isaiah at chapter 9 states the following at verses 6-7.

Isaiah 9:6-7

- ⁶ For unto us a child is born, unto us a son is given: and the government shall be upon his shoulder: and his name shall be called Wonderful, Counsellor, The mighty God, The everlasting Father, The Prince of Peace.
- ⁷ Of the increase of his government and peace there shall be no end, upon the throne of David, and upon his kingdom, to order it, and to establish it with judgment and with justice from henceforth even for ever. The zeal of the LORD of hosts will perform this.

The Throne of David

We have discovered that Freemasonry has substituted "King Solomon of Israel" into this Scripture in relation to "The Government" and has shut Jesus Christ out disregarding any or all New Testament evidence that the person any spirit of Jesus Christ is the carrier King of Israel. You have failed to discover and reveal this.

The name of Solomon

We have discovered that every Masonic Lodge is opened in the name of "King Solomon of Israel" omitting and barring the name of Jesus Christ you have failed to discover and reveal this substitution.

Almighty God

We have discovered that contained within the Preamble of the Constitution of the Commonwealth of Australia are the words "Humbly relying on the blessing of Almighty God" which is the reason why the Lord's Prayer is said in the Commonwealth Parliament each day, but, apparently the atheist component come in <u>after</u> the prayer.

The Supreme Being

The Land

We have discovered that there are many King James translation scriptures. Relating to "The Land" in particular Deuteronomy chapter 8:1-3 and 2 Chronicles 7:14 and Micah 2:1-2

Deuteronomy 8:1-3

King James Version (KJV)

8 All the commandments which I command thee this day shall ye observe to do, that ye may live, and multiply, and go in and possess the land which the LORD sware unto your fathers.

¹⁷ They also went down into hell with him unto them that be slain with the sword; and they that were his arm, that dwelt under his shadow in the midst of the heathen.

Power / Wealth / Nations

We have discovered that the Seven Nations mentioned in the Scriptures are the United Nations today assembled to destroy <u>ALL</u> of the children of Almighty God (The Father).

One scripture seems to cover all of this. The discovered fact has been concealed by all of you.

Deuteronomy 8:17-20

17 and thou say in thine heart, My power and the might of mine hand hath gotten me this wealth.

18 But thou shalt remember the Lord thy God: for it is he that giveth thee power to get wealth, that he may establish his covenant which he sware unto thy fathers, as it is this day.

The Crown

We have discovered that "two crowns" exist in Legal and Constitutional terms

- 1. The Crown of the United Kingdom
- 2. The Crown of the City of London

The first one is both a constitutional crown <u>and</u> at the same time the monarchy of such crown is <u>the head</u> of the church of England <u>or Anglican Church</u> which apparently has no legal basis whatsoever except for "The Creed".

The second crown emanates from the "City of London", a separated city similar to "Vatican City" in Italy and <u>possibly</u> Jerusalem in Israel.

All are Masonic cities in particular Jerusalem identifies by the King James translation at Isaiah 28:14-17

15 Because ye have said, We have made a covenant with death, and with hell are we at agreement; when the overflowing scourge shall pass through, it shall not come unto us: for we have made lies our refuge, and under falsehood have we hid ourselves:

16 therefore thus saith the Lord God, Behold, I lay in Zion for a foundation a stone, a tried stone, a precious corner stone, a sure foundation: he that believeth shall not make haste.

17 Judgment also will I lay to the line, and righteousness to the plummet: and the hail shall sweep away the refuge of lies, and the waters shall overflow the hiding place.

The Federation Crown

We have discovered that about 1850 the colony of New South Wales (the land of Australia) was created by an Act from the Imperial Parliament (The Constitution Crown) and from such act flowed the various acts creating each colony.

At Federation all colonies within that land of Australia agreed to submit their respective colonies into the Federation agreement, the last colony to submit and agree was Western Australia. It was reluctant because it knew that most of the known gold resources were in Western Australia but Western Australia did come into Federation evidenced by the fact that Senators and House of Representatives come into Canberra from Western Australia.

High Court 1999

We have discovered that during the year 1999 (the same year of the United Nations Decree) the judges of the High Court in the *Sue vs. Hill* matter ruled that England is a "Foreign Power" to the Constitution.

The Last Referendum

11. A person who is appointed as a Justice after the commencement of this Act shall, before proceeding to discharge the duties of his office, take an oath or make an affirmation in accordance with the form in the Schedule.

Commonwealth Constitution Section 5

COMMONWEALTH OF AUSTRALIA CONSTITUTION ACT - SECT 5

Sessions of Parliament. Prorogation and dissolution

The Governor-General may appoint such times for holding the sessions of the Parliament as he thinks fit, and may also from time to time, by Proclamation or otherwise, prorogue the Parliament, and may in like manner dissolve the House of Representatives.

Summoning Parliament

After any general election the Parliament shall be summoned to meet not later than thirty days after the day appointed for the return of the writs.

First session

The Parliament shall be summoned to meet not later than six months after the establishment of the Commonwealth.
